**Per City Ordinance**

[15-1-45-Electrical Installation by Homeowner.](#)

- (1) A homeowner may install wiring in the homeowner's own home, provided that, in the opinion of the Electrical Inspector:
  - (a) The homeowner has reasonable knowledge of such work.
  - (b) The homeowner occupies the dwelling at the time the work is being done.
  - (c) The signature on the permit shall be that of the owner who shall do the work, or the person's child, parent or spouse.
  - (d) Any new installation or alterations to the service entrance equipment must be done by an electrical contractor licensed in the City of Oconto.
  - (e) Any new installation of an underground feeder or any circuit feeding swimming pools, spas or hot tubs shall be done by an electrical contractor licensed in the City of Oconto.

[15-1-43 –Standards for Electrical Equipment.](#)

Only that equipment which has been expressly made for electrical purposes shall be installed for electrical purposes. All electrical equipment shall be installed or used in the exact manner and for the exact purpose indicated by the manufacturer's instructions, markings or labels. No equipment or devices shall be sold or utilized which is not approved by a nationally recognized testing laboratory. Old or secondhand electrical equipment shall not be installed unless such equipment is in a safe condition as determined by the Electrical Inspector. The original manufacturer's ratings, markings or labels thereon shall not be changed or altered in any manner; except that normal repairs and replacements may be made to such equipment if the replacements and repairs do not change the original characteristics and design.

All wiring shall be done according to Wisconsin State Electrical Code and the Code of the City of Oconto.
