4. Approval of Minutes from the 10/10/16 Meeting

Moved by Hayes, seconded by Thompson to approve the minutes as typed. Motion carried upon verbal voice vote.

5. Public Input/Correspondence

Thompson would like the Committee's mission statement to appear at the top of all future agendas.

Jim Lacourciere was present on behalf of the Historical Society to inform the Committee about a reenactment to be held at the Beyer Home on May 12-14, 2017. The time period will be from 1750-1820 and there will be camping, a trading post, dancers, etc. At this time, no financial help is being requested and the event will be free to the public. The consensus of the Committee was that this is a great idea.

Hayes addressed the power for the sign at Holtwood. He is still waiting to hear back from the electrical contractor and may opt for solar power if it is more cost effective.

Thompson stated that Figueira is working on other design options for the roundabout and will be bringing them to the Committee for review. Perrizo spoke with J. Wusterbarth who can get approval from the DOT to place the structure.

- 6. Discussion/Possible Recommendation on:
 - a. City Sign Ordinance

The Committee addressed the ordinance page-by-page. Regarding fees to put up a sign, the current cost of 50 cents per square foot was thought to be excessive and the Committee recommends a flat fee of \$200. Other recommended changes are as follows:

- Remove the yearly licensing requirement for sign installers;
- Remove the requirement that the Council pass a resolution to set the permit fees;
- Remove the prohibition of swinging signs and floodlighted signs;

- Remove the requirement that supports and braces shall be hidden from public view and that no guy wires or chains may be used for support;
- Remove the requirement that all signs must be marked with the manufacturer's name in a size that is easily visible from the ground;
- Remove the prohibition of portable advertising signs being used on a permanent basis;
- Remove the area restrictions of signage in commercial and industrial zoned districts;
 and
- Remove the separate restrictions for the Main Street Commercial District.

Moved by Thompson, seconded by Hayes to change the fee for all sign permits to \$200, remove section 13-1-143(a), remove the wording "resolution of City Council" in section 13-1-143(d) and include "as stated in the permit fee schedule", remove 13-1-147(2) and (3), remove 13-1-147(4)(a), remove 13-1-149(e) (f) and (g), remove 13-1-152(3), remove 13-1-153(3)(b) and remove all of 13-1-154.

Motion carried upon verbal voice vote.
