7. Discussion/recommendation/action on the following:

a) Parks & Recreation

i. Update on Skateboard Park/Fundraisers for Bike/Skateboard Park— V. Bostedt began with Winterfest success including raffle, 17 chilies, and attendance. The fund raiser was for the Skateboard/BMX Park. She thanked Tere Hockmuth for her volunteerism. The event net \$1,203.25 last year; donation cards throughout the City added \$353.80; \$1,000 is a Kiwanis pledge; \$50.00 came from Mayor Lloyd Heier; 2017 Winterfest totaled \$1,258.70 with a now visible total of \$3,865.75. The goal is \$12,000 to pour the concrete foundation. Bostedt has spoken to various clubs/organizations for donations. Brother's III April pizza-of-the-month will be dedicated toward the Park. The Park's group will hold their next fundraiser March 25, 1 p.m. @ OHS: Park and Rec. with Utility vs. Police/Fire Departments in a basketball game. Funds will come from entry, tee shirts, concessions, and a basket raffle. The City Hall Girls will be showing their presence and possibly coaching as well. All major Skate Park sponsors will be posted at the building site. Administrator Perrizo duplicated a handout showing specs/costs. The Bond Foundation will have input. Park promoters plan to set concrete by fall.

Hockmuth motioned the Winterfest monies remaining after expense will be donated to the Oconto Skate/BMX Park. Motiff called second. 3 Ayes

Anderson sent informative articles to the paper. Note that future Winterfest events will have recycling containers.

b) Aageson Pool

c) Holtwood Campground

i. Update Bathroom/Shower Building— Administrator Perrizo suggested \$114,000 be spent toward the project; the balance would be put on a bond and then begin construction. The Committee felt that money needs to be greater in the 2017 fund for needs at the facility.

Motiff motioned to utilize \$100,000 out of the Holtwood fund balance and that we bond \$50,000 for the balance of the cost to build the Holtwood Campground bath/shower/laundry/storm shelter building. Hockmuth resounded with a second.

Chairman Hearley and Director Bostedt will meet to get specs within the next week. A gaming room elsewhere in the future is speculated.

- ii. Big Stumps in Campground— Hearley suggested we hire a wood carver to create a jumping fish and eagle out of the remaining stumps rather than grind them out. Given a curing period, the statues will be sealed. Hearley will seek some pricing. (A contest of another of the carver's work (donated) could create funds for future "dead wood".)
- iii. Reservations 2017— We have a waiting list for Memorial Weekend sites with tenting yet in the overflow area open. Hearley suggested Bostedt look at the overflow area for water and utility development and note potential cost.
- d) City Park/City Park Campground— On site building improvements are being anticipated for end of March/early April, weather permitting.
- e) Holtwood Sporting Complex is being spread with dirt piles by the river in the Disc Golf site. This direction is acceptable. The culvert will be fixed but continue with water drainage as that is necessary to the location.
