7. Discussion/recommendation/action on the following:

- a) Parks & Recreation
 - i. Update on Skateboard Park/Fundraisers for Bike/Skateboard Park—City workers basketball fund raising game with raffle, sponsors, tee shirts, bake sale grossed \$2,700. Superintendent Wusterbarth and Director Bostedt are anticipating the ground foundation: we must check into anchor needs.  - vi. Pool Improvements or Projects 2017— Our concessions machine has been repaired. Our Splash Club bought-off leftovers from the Bike/Skateboard basketball fundraiser game.
 - vii. Lifeguards for 2017— We only lost 1. The H.S. class is still in session; they represent 5 potential guards.
- b) Holtwood Campground
 - i. Update Bathroom/Shower Building— Hobbs presented the updated State Grant application. We need to fill in the resolution and present it to Council. Wusterbarth is in process with the yet necessary boundary map to be included. Hobbs stated that the Grant award will be in October or November. Intent is to have the building for the 2018 season.
