Dear Mr. Wusterbarty,

Thank you for the opportunity to present this Phase 1 proposal to pull, inspect and evaluate the pumping equipment in your Well #7, and TV inspect the well casing and borehole to determine if cleaning / rehabilitation is warranted at this time.

The scope of work covered by this proposal is as follows:

- 1) Mobilize to the site with a 2 man crew, pump rig and support vehicle.
- 2) Conduct a performance test on the well and pump to establish a baseline for capacity.
- 3) Remove pumping equipment from the well and transport to WWS shop for teardown, cleaning and inspection. Following the inspection a detailed report and list of recommendations will be prepared and submitted for your review and consideration. No repairs will be made without authorization by the City.
- 4) Conduct a downhole television survey of the well casing and borehole to determine the extent and composition of mineral and biological deposits and to determine the integrity of the well casing itself.
- 5) If it is determined by the capacity test and TV inspection that well redevelopment is warranted at this time, develop program to clean the well using chemical and mechanical methods.

The estimated cost for this Phase 1 scope of work is between Eight Thousand Five Hundred Dollars (\$8500.00) and Nine Thousand Five Hundred Dollars (\$9500.00) barring unforeseen circumstances.
