- 5. Public Input: Jeremy is holding retainage money of the Holtwood Park Construction from the contractor. Landscaping is not up to Jeremy's standards and would like to do a walk through the contractor.
- 6. Correspondence:
 - a. Update on Construction Projects: McDonald Street- underground work is done except for by the railroad tracks. Asphalt is 96% complete as of 8/20/2018. Dorner, Inc. subcontracted RC Excavating & they were doing the landscape and Jeremy told Dorner that they needed to get rid of them or to do a better job, Dorner got rid of them. Dorner is hydro seeding and asking the residents to help out with the watering with being so dry. Concrete is looking good, had to have 180 feet removed the grade was not right, not sure what happened. Friday, August 24th is the end of the contract days but don't want anyone driving on the new blacktop so Monday, August 27th or Tuesday, August 28th will be the last contract day. Chairperson Anderson had a few people complain that the project is taking too long. People don't understand how the underground work works, it takes time.

Lindsey Ave & Washburn: Underground done on Lindsey. Washburn should be done 8/23. Road crew in on 8/22. Will be having a change order for Lindsey Ave. Lot of clay & bad soils for blacktopping. Looking into putting geofabric down before blacktopping. Will help with the moisture, \$1.35-\$1.50 a yard. Help in the long run, will have a bad road in 7 years. Washburn soil is good.

b. E-Cycle Annual Report to the WI D.N.R: The first report to the DNR is due by August 1st, for the electronics. Take most of our stuff to Sadoff. We charge the customers what Sadoff charges us.

From Collins Ave to Pine Ave. Will be doing curb & gutter on the City side of the road the Town of Oconto can do whatever they want. Sidewalk from Elm Ave to Collins Ave. Barbara Wittkopf has a few concerns; she feels that when the Elementary school got built she lost some of her property, she would like her driveway paved. Jeremy told her cannot do that can ask the BPW & Council if they would approve it. Jeremy talked to the Superintendent of the schools about give us the land and won't charge them for the assessments. No action needed just want the committee aware of the upcoming project.
