DEFINITIONS

Minor alterations	Where the cost of alterations or improvements for the project is less than 25% of the cost of increasing the area of the building, if over 25% Misc. Section #5 shall be used to determine the cost of the building permit part of the fee.
Alterations	Where the nature of the project is to make improvements to that are appraised over 500.00 and Misc. Section #5 shall be used for purposes of determining the building portion of the fee.
Process Fee	When plans are examined at the State of Wisconsin offices, the process fee is charged by the City office for local review.
Plan Approval	Where the building is less than 25,000 cubic feet, the City office may do a Commercial building code plan review and charge for same.

Permit Applications can be obtained by stopping in at the City Inspection Office, via fax, email and are printable from the City web site www.cityofoconto.com.
