 - a. Guidelines for Barn Wedding Venue

Last reported that he, Calvert and Perrizo went through the ordinances and found those that are existing that apply as well as some other that could be added. Things considered included buffer zones, noise and parking. The difference between this venue and having a wedding at a residence is that this venue is a commercial facility. Schreiber feels that the 10 p.m. noise ordinance should be maintained and no variances given. That way, the decision of whether the noise ordinance is being violated is left to the discretion of the police officers.

Last stated that the owners of the barn may put up tents this summer to host events in order to create revenue to go toward renovating the barn. Bronikowski noted that, if there is an outside area, that is where people will congregate. Schreiber thinks the owners will try to accommodate the neighbors. Last suggested allowing one or two events to be held and then go from there. The committee agreed.

Moved by Perrizo, seconded by Heier to inform the barn owners of the city's expectations, get a plan from them and then allow up to two events to be held before review.

b. Political Sign Ordinance

Calvert provided a draft revised ordinance that states that signs may be put up not more than 90 days before an election, must be removed within 30 days after the election and the size of the signs can not exceed 16 square feet in residential districts and 32 square feet in non-residential districts. Giving 30 days after the election to remove the signs will lead to close to 60 days after due process (letter, citation and court date) is followed.

Moved by Bronikowski, seconded by Rehberg to approve the draft political sign ordinance.
