- 1.) The February meeting was called to order by Chairman Sasse @ 8:08 a.m.
- 2.) Roll Call: Nick Badendick, Tom Sasse, Susan K. Seidl, Jeff Werner. Also Present: Director of Forestry, Parks and Rec. John Bostedt
- 3.) Seidl motioned for approval of Agenda. Werner called second. (4 Ayes)
- 4.) With the correction of 6.) b.) it was noted that where we live in WI is labeled at the 4/5 boarder of hardiness climate zone location. We followed with this correction; approval of Meeting Minutes from 01/13/2022 was submitted by Sasse with a follow-up second of Werner. (4 Ayes)
- 5.) Public Input: None.

## 6.) Correspondence:

- a.) Northeastern WI Forest Health Update WI DNR ((2) January highlighted Oak tree pruning in winter: helps prevent Oak wilt. February informed how to avoid invasive plants. It stated that WI prohibits sale of 145 plants which have invasive, ecological, or human health harm: *one is to watch buying them @ nurseries*.
- b.) Wisconsin Pollinators ((2) 1/17/22 "Native Flowering Shrubs": there are 18 in WI; Nematodes; Honeybee risk; soil structure; pollinator color preferences; Hummingbird quiz; and the benefit of garden earthworms. 2/1/22 "It's Groundhog Day" included a quiz on the subject; earthworm problems; Feb. beekeeping; 18 spring garden blooms; compost tea; and Climate Change with WI winters.
