- Mayor Panetti asked for a round of applause for the volunteer efforts of Firefighter Cody Henry, Firefighter Gavin Kuerschner, Officer Brad Scherer, and Sheriff's Department Deputy Miller who participated with the surrounding areas with Police & Fire escorts awaiting on over-passes with flashing lights welcoming the 5 WWII veterans' bus on their way to the LCS 29 USS Beloit christening
- Garrett and Courtney Sowle presented a Power Point presentation explaining their upcoming rezoning request for 116 Holtwood Way property: "The Yard Park and Bier Garden on the Oconto River". This Petition for Zoning Amendment and Liquor License Application will be on the June 14th Plan Commission and Council meeting agendas.
- Jeremy Wusterbarth handed out a list of upcoming 2022 events and street closure requests. The City received \$14,541 for a 2022 Recycling Grant. Congress Street project was put on hold for 2022: After talking to the State on the LRIP grant, the funds can be used thru 2026. We were awarded an 80/20 grant for Arbutus Street. From Madison St to Memorial Dr. Out of the estimated \$310,000 total costs for the 2023 project, the City will be responsible for

only \$70,000. A grant for VanDyke, from Cook Ave to Percy Ave, is going to be written pending response from the DOT if the project needs to be completed in 2023 or if we can extend it out to 2026. It would also be an 80/20 grant. Out of the estimated \$600,000 total costs, the City will be responsible for only \$120,000. There are a lot of grants being offered right now, that Wusterbarth has never seen in the 20 years working for the City of Oconto.
