

# Oconto Breakwater Park and Harbor Rules

In order to provide a pleasant and safe atmosphere for those persons utilizing the facilities of the Oconto Breakwater Park and Harbor, the following rules shall be observed by the persons who for any reason be in, on, or about the Breakwater Park and Harbor premises and its contiguous waters.

- 1. Registration of vessel and assignment of slips:** All Vessels entering the Breakwater Park and Harbor must be registered with the Harbormaster or Park and Recreation Director and assigned a slip. The Harbormaster or Park and Recreation Director may reassign slips in such manner as deemed necessary.
- 2. Docks:** The docks are to be used solely for the purpose of obtaining access to or tending a vessel.
- 3. Docks:** Your boat/pontoon and motor must be inside of the end of the dock if anything, closer to the wall.
- 4. Swimming and fishing:** There should be no swimming, diving, or fishing from the docks or walkways.
- 5. Sanitary Waste:** Any direct discharge of vessel's waste in the Marina is strictly prohibited.
- 6. Conduct:** Disorderly, noisy and indecorous conduct is strictly prohibited. All persons shall refrain from acting in any manner which might result in the injury or disturbance of other person and/or damage to another vessel. Radios, televisions or other sound emitting devises must not disturb other persons.
- 7. Pets:** Pets shall be toileted on the grassy areas and solid waste must be picked up after. Pets must be on a leash at all times. Pets may not be chained or left on docks or sidewalks nor fed or watered except aboard owner's boat. Owners are responsible for any damage or disturbance their pets may cause.
- 8. Liability:** All persons making use of Breakwater Park and Harbor facilities do so at their own risk. Breakwater Park and Harbor assumes no liability nor shall it be in any way responsible for any damage or injury resulting from the condition of the marina facilities.
- 9. Emergency Repairs and Salvage:** Breakwater Park and Harbor assumes no responsibility in the event of a vessel taking on water, burning, or sinking in the harbor but should such event occur then the Harbor Master or Park and Recreation Director may, at his discretion, take such emergency action as deemed necessary. Such action(s) will be billed to the boat owner.
- 10. Responsibility for damage or injury:** Any person causing damage or injury to harbor facilities, personnel or to the property or person of others utilizing the harbor facility shall be responsible for the total cost involved in repairing such damage.
- 11. Harbormaster:** The Harbormaster or Park and Recreation Director has the authority to interpret and enforce these regulations and all persons and vessels entering the Breakwater Park and Harbor shall be subject to his direction.
- 12. Insurance:** Owner shall carry general liability insurance (\$300,000.00 Minimum) to satisfy any and all claims for injuries to persons or property occurring in, upon, or about the owner's boat during the agreed term and there shall be delivered to the Marina, upon request, customary certificates evidencing such paid-up insurance.
- 13. Miscellaneous:** Boating "Rules of the Road" shall be observed at all times; no wake restrictions will be strictly enforced.
