Wittkopf asked about the status of the storm work because of the water. Wusterbarth explained the storm work is still being completed, it is taking a little more time because a majority of the outfalls going out to the river are underwater. The storm mains are about 50% full of water, when replacing storm inlets and they are opened, it creates an issue with the amount of water flowing. It's been a struggle to get the structures in place. Sandbags are being utilized. They have completed the majority of them this week. As they are getting further North, the elevation is higher and water is less and less of an issue, which speeds the process up. The water put us back about 2 weeks on the project. Wittkopf asked if these issues would affect the cost of the project. Wusterbarth explained "no". It is the responsibility of the contractor to fully inspect the project, they open up storm & sewer manholes, ask questions, and examine water vs dry soils and base the bid price accordingly.
