He explained they are combining the 2 parcels and extending the road right-of-way up further to allow the Sowles access to the property. A concern regarding the drainage ditch was asked - Wusterbarth explained the drainage ditch is on City owned property and will not be affected.

d. Petition for Zoning Amendment from Courtney & Garrett Sowle to Amend the Zoning for Parcels #265-33240752157M and #265-33240752157R from Residential Single Family (R1) to Recreational (REC)

Garrett and Courtney Sowle presented a 25-minute Power Point presentation (which is available for viewing at the office of the City Administrator). Wusterbarth asked if the would be required to apply for a Conditional Use Permit if the Ordinance was changed to allow a beer garden, would that CUP go thru the Plan Commission before going to Council - Bickel answered "correct" - attorney Calvert corrected "not to Council, only approved or denied by Plan Commission". Werner expressed concern of the neighbors being "sandwiched" between The Riviera outdoor event venue and this potential beer garden with food trucks and both with potentially a lot of people attending. Bake asked if it was spot zoning. Joe Last answered "no", it is adjacent to Recreational property. There was back and forth discussion between many of the public attendees that started to get loud and tense. Order was called by the Mayor. It was decided to forward the decision on to the Council for them to decide.
