- Local Government 101 Webinar Scheduling Bickel reminded the Council and Mayor that the League of Wisconsin Municipalities is hosting a webinar for new and long-serving elected officials that is strongly suggested everyone attend. We have 12 months to watch the webinar and have the option for one or multiple nights. Alderperson Feldt stated she has taken it before, and it is extremely informative and would like to see everyone there.
- Jeremy Wusterbarth The DOT has contributed an additional \$28,000 to the Arbutus Project 80/20 grant which will be taking place next year. The Oconto Marsh is cut 2-3 times a year by the City. Wusterbarth spoke with a representative regarding the rough shape the dyke is currently in. Ducks Unlimited will be working on repairing the Northwest, West, and Southwest areas. The project is going on right now and will be finished up by Fall.
- Mayor Panetti The NERR has not been awarded to the City of Oconto.
- Dave Dreshek, 234 Frank St, spoke regarding the Oconto Pedestrian Bridge, in favor of allowing all ATVs and UTVs across.

The Mayor suggested we appoint three people to go on an interview team to interview other newspapers, along with the school.
