#### Discussion/Recommendation/Update on -

a. Expenditure Guidelines and 2023 Budget: We have 4 tornado sirens - two are 40/50 years old by Pecor/Farnsworth and the Wastewater Treatment Plant, one is 20 years old by the School, and one is 10 years old by Copper Culture State Park. Chief Rehberg reported the County was thinking about changing companies from Code Red, they recently however determined they are staying with Code Red, so education, sign-up, and training efforts will begin immediately. Our Student Resource Officer will be educating and signing up students and teachers at the Schools. Chief Bostedt reported that currently all the sirens are operating. The two oldest ones are non-serviceable and would need to be totally replaced. The newest one at Copper Culture needs adjustments to the wiring and drip legs would need to be installed to bring them back up to code. The one at High School would also need small maintenance and updates. We are not mandated by State Statute to have and maintain tornado sirens. The Committee unanimously agreed to phase out the sirens and educate the public on utilization of Code Red.
