Public Input -

• Utility Manager Matt Beekman mentioned an issue that we became aware of today around 2:00 pm when they were doing locates for WPS to do electrical for The Yard. The pedestal/service box was installed in our Water Main Easement, approximately 6 feet off the property line of the Hornblads, the easement is 10 feet wide beginning at the property line. The Water Main was installed in 1995. We would have caught this sooner, but Diggers Hotline was never contacted before doing the work,

therefore a locate request was never put in. Vandenlangenberg asked when the utility service was placed there. Beekman responded it was installed by Scheffen Electric around March 30th he thinks, but he isn't sure on the exact date, it was over the weekend. We left a voicemail for Scheffen Electric as soon as we became aware of the issue. VanCampenhout stated to resolve the issue as soon as possible, before WPS hooks up the power, to avoid more difficult issues being created. The Commission agreed. VanCampenhout stated it will cost the property owner a lot more in the future if they need to move it because we need to dig up the Water Main.

• Wastewater Operator in Charge Ben Thome went over the details of the Wastewater Treatment Plant Upgrade that is coming up.
