Administrator Burruel explained there is no need to take out additional debt. After much consideration and research, speaking with Ehlers, contemplating borrowing from our Utility, a better solution has been discovered. In 2023, we budgeted for two road projects. Being without a Superintendent of Public Works for much of 2023, only one road project was completed. Because of this, there is money available in our Capital Fund that can be used for the 2023 debt payment. This will save us significant fees and interest.
