- 3. Approval of Agenda: Earl moved to accept. Seconded by Kevin. The motion was voted and carried 5/0.
- 4. Approval of Minutes from Previous Meeting of November 6, 2023. Bob moved to accept. Seconded by John. The motion was voted and carried 5/0.
- 5. Correspondence: Airport received Notice as to Conditional Use Permit for 2934 Airport Road.

- 7. Discussion/recommendation/approval of Department Reports:
