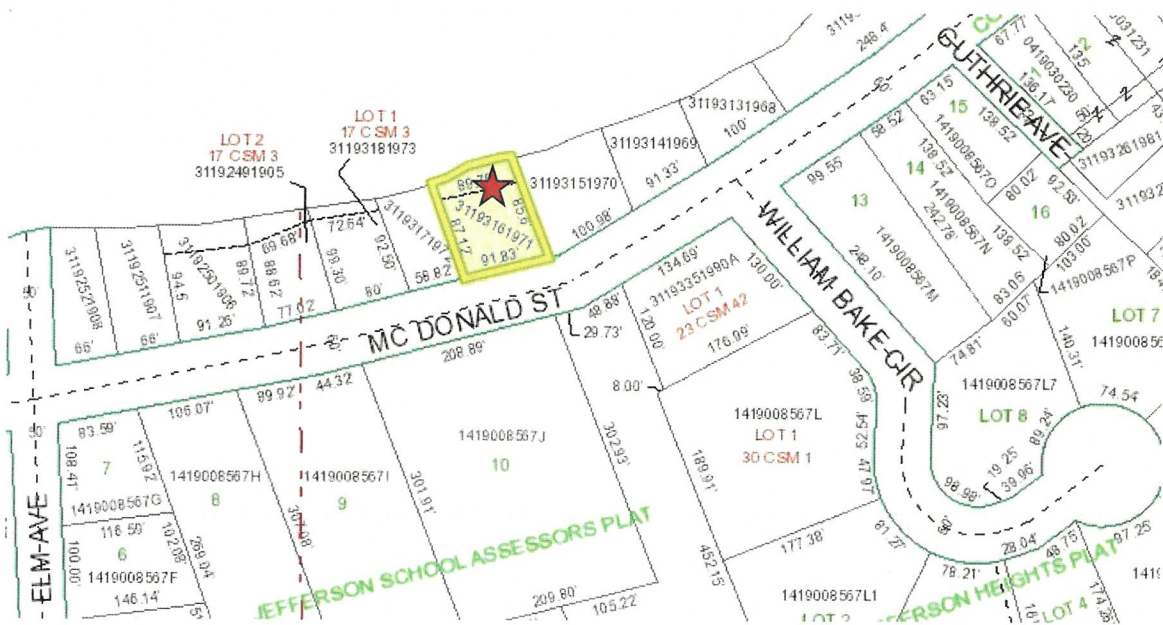

Guidelines for Issuance of Kennel License:

Proper food, water, and shelter are provided. Indoor standards for ambient temperatures and ventilation are met. Outdoor standards for shelter from sunlight, shelter from inclement weather, space requirements, and sanitation standards are met.

Nuisance restrictions are met: no running at large, no excessive noise, no soiling of public property and private property not owned or rented by the pet owner, and no noxious odors or unsanitary conditions caused by failure to clean dog's resident property. Dogs must be prevented from causing a nuisance by barking, howling, or yelping in a habitual, consistent, or persistent manner that continually disturbs peace in the neighborhood.

Confinement restrictions are met: Dogs will be securely confined, leashed, or under control of a competent person over the age of 16 at all times. Fences are sufficient in height and strength to safely contain dogs. Underground fences are not sufficient to contain unsupervised dogs. Dogs will not be tethered as a primary method of confinement.

I certify that I, the undersigned, have received copies of the City of Oconto Municipal Code relating to animal control and understand that I am responsible for prevention of a barking nuisance, dog litter, keeping animals from running at large. Violation of the Codes could result in revocation of Kennel License and/or issuance of citations.

By virtue of the application, I agree to an on-site inspection by the Local Health Officer or Animal Control Authority of the premises where animals are kept on an annual basis or whenever a complaint has been registered.

I agree to amend this application if the number of dogs that this license is issued for increases.

I certify that all the dogs at this premises are and will be vaccinated against rabies by a veterinarian within 30 days after the dog reaches five (5) months of age and revaccinated with one (1) year after the initial vaccination.
